JOB OPPORTUNITY

POSITION: Social Worker III (Adult Services Unit)

LOCATION OF POSITION: 1000 North First St., Suite 2
Albemarle, NC 28001

SALARY: \$36,597 – \$54,896

DUTIES/RESPONSIBILITIES: This Social Worker III position in the adult services unit is responsible for receiving and evaluating reports of alleged abuse, neglect, or exploitation of disabled adults. Worker serves as Adult Home Specialist responsible for monitoring and licensing of adult home care facilities in the county. The position provides case management services to in-home aide clients and also provides placement services to adults who are unable to remain in their own homes. Worker provides guardianship services to adults for whom DSS is legal guardian. Worker provides payee and At-Risk Case Management services. Referrals are made to other units in the agency or various community resources as necessary. This worker serves as back up for emergency intake services during office hours. The social worker serves on-call on a rotation basis with other staff to receive reports involving allegations of abuse or neglect of adults after hours and on weekends. The worker has regular contact with medical providers, law enforcement and other community agencies that serve adults. Competency in computer skills required.

MINIMUM EDUCATION AND EXPERIENCE REQUIREMENTS: Master's degree from an accredited school of social work and one year of social work or counseling experience; Bachelor's degree in social work from an accredited school of social work and completion of the Child Welfare Collaborative (Child Welfare positions only); Bachelor's degree in social work from an accredited school of social work and one year directly related experience; Master's degree in counseling in a human services field and one year of social work or counseling; Bachelor's degree in a human services field from an accredited college or university and two years directly related experience; Bachelor's degree from an accredited college or university and three years of directly related experience.

Applicants who meet the qualifications listed for the Social Worker III will be given first consideration. Also, those with a Social Worker degree from an accredited school of social work will be given preference; however, anyone who has a Human Services Degree or a 4-year degree may apply as “work against appointments” and will be considered.

ADDITIONAL REQUIREMENTS: Must have valid NC driver's license and reliable transportation. All applicants tentatively selected for this position will be required to submit to a urinalysis to screen for illegal drug use, a criminal records check will be conducted and a driver's license check may be completed. **Official transcript must be included with the application.** Must be flexible in work hours.
