POSITION: Wastewater Treatment Plant Operator in Responsible Charge (ORC)

SPECIFICATION: Responsible for serving as wastewater treatment plant ORC. Performs maintenance and repair and inspection of sewer collections system with special emphasis on lift stations operations and maintenance. Considerable knowledge of the operating requirements of a wastewater treatment plant and sewer lift stations. Supports overall work of Utilities operations. Performs other related tasks as required. Considerable knowledge of tools, materials and equipment used in the installation, replacement, maintenance and repair of a wastewater treatment plant and utility collections systems. Considerable knowledge of the use of common hand and power tools. Some knowledge of municipal sewer service policies and procedures. Must be able to physically perform the basic life operation functions of climbing, balancing, stooping, kneeling, crouching, crawling, reaching, standing, walking, pushing, pulling and lifting. Must be able to perform very heavy work exerting up to 100 pounds of force occasionally and 50 pounds of force frequently. Must possess ability to operate mobile equipment such as loaders in a safe manner read gauges and keep written records.

DESIRABLE EDUCATION AND EXPERIENCE: Graduation from high school with a grade III wastewater treatment plant certification and grade II collections certification or the ability to obtain within 12 months.

SPECIAL REQUIREMENTS: Possession of a valid North Carolina driver's license. Willingness and ability to obtain additional certifications as required by the County.
