**POSITION:** Utility Systems Worker/Distribution & Collections System Operator

**JOB SPECIFICATIONS:** Duties include taking distribution samples for water system; reads water meters; performs maintenance and repair and inspection of water lines, meters, hydrants, and valves; takes water samples and checks for chlorine content. Operates heavy construction equipment requiring skill and care around parked cars and overhead and/or underground utility lines; operates front end loader, dump trucks, jackhammers, tampers, pipe threading machines, tapping machines, trenchers, air compressors, and boring machines. Serves as a lead worker to make water and sewer taps, unstop or clean sewer lines, replace or maintain hydrants and valves, or other related tasks. Lays water and sewer pipe; adjusts pipe to proper grade and depth with laser; repairs and replaces sewer and water lines and related facilities. Installs, services and tests water meters and meter yokes. Installs hydrants, meters, valves, clamps, and related pipeline apparatus; sets meter boxes; repairs and replaces fire hydrants. Maintains assigned truck properly stocked and in proper operating condition. Keeps customers informed when water service is turned off for repairs. Locates lines and assists with inspection and repair of pumping stations, reading water meters, and other related tasks.

**MINIMUM QUALIFICATIONS:** Graduation from high school and considerable experience on construction related utility work; or an equivalent combination of education and experience. Must be able to perform heavy work exerting up to 100 pounds of force occasionally, 50 pounds of force frequently and 20 pounds constantly to move objects. Must possess the visual acuity to operate mobile equipment and read gauges. Must be able to perform basic life functions of climbing, balancing, crawling, lifting, etc.

**SPECIAL REQUIREMENTS:** Possession of valid North Carolina class C driver's license, a water distribution and/or sewer collection operator certification or ability to obtain within 18 months of employment. Applicants hired without active certification will be hired as a Utility System Worker until required certification is obtained. Additional certifications will be required as a part of the continued job duties in the future. All applicants tentatively selected for this position will be required to submit to urinalysis to screen for illegal drug use prior to appointment.
